WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) in the sum of ---TWENTY-EIGHT THOUSAND THREE HUNDRED FIFTY and 10/100--- DOLLARS (\$ 28,350.00 ), with interest thereon at the rate of seven & three/100ths per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as Lot 13 on plat of POTANY WOODS, INC. as shown by plat thereof recorded in the RMC Office for Greenville County, S. C., in Plat Book "YY" at Page 173, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Kingsridge Drive at corner of Lot No. 12 and running thence S. 20-39 E. 276.6 feet to an iron pin; thence S. 72-39 W. 90 feet to an iron pin; thence N. 22-44 W. 276.2 feet to the south side of Kingsridge Drive; thence with the south side of said Kingsridge Drive N. 72 E. 100 feet to the beginning corner. Being the same property conveyed to the grantors herein by deed recorded in Deed Volume 838 at Page 230 in the RMC Office for Greenville County, S. C.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part of the debt secured by the mortgage.
