(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto W.N. Leslie, Inc.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Five Thousand Nine Hundred Eight and No/100 --- DOLLARS (\$ 5,908.00)
with interest thereon from date at the rate of 8 3/4 per centum per annum, said principal and interest to be repaid:
