and Alene R. Bolin (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Lynhurst Drive, being shown and designated as Lot 57, Section One, on a Plat of OAK CREST, recorded in the R.M.C. Office for Greenville County in Plat Book GG, at Pages 110-111, and having the following metes and bounds:

BEGINNING at an iron pin on the northern side of Lynhurst Drive, joint front corner of Lots 56 and 57, and running thence N 29-58 W, 86.2 feet to an iron pin; thence N 17-42 E, 94.6 feet to an iron pin; thence N 60-02 E, 10.2 feet to an iron pin; thence S 29-58 E, 150 feet to an iron pin on the northern side of Lynhurst Drive; thence along Lynhurst Drive, S 60-02 W, 80 feet to an iron pin, the point of beginning.
