WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Hunting Hollow Road, near the City of Greenville, being shown as Lot No. 112, Section I, Foxcroft, on plat recorded in the RMC Office for Greenville County in Plat Book 4F at pages 2, 3, and 4, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the southern side of Hunting Hollow Road, said pin being the joint front corner of Lots 111 and 112 and running thence with the common line of said lots S 10-09 E 165 feet to an iron pin; the joint rear corner of Lots 111 and 112; thence S 79-51 W 125 feet to an iron pin, the joint rear corner of Lots 112 and 113; thence with the common line of said lots N 10-09 W 160.9 feet to an iron pin on the southern side of Hunting Hollow Road; thence with said Road N 72-44 E 33.5 feet to an iron pin; thence continuing with said Road N 79-51 E 91.7 feet to an iron pin, the point of beginning.
