(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, being shown as Lot No. 3, Section 2 of Belle Terre Acres on plat by C. O. Riddle, Surveyor, dated July 1964, revised October 1965, containing 1.89 acres, and having the following metes and bounds, to-wit:

BEGINNING at a point in the center of South Carolina Highway 106, which point is 204.8 feet east of the joint corner of Lots Nos. 4 and 5, and thence with the line of Lot No. 4, S 7-40 W 384.2 feet to an iron pin; thence S 85-20 E 225 feet to an iron pin in the joint rear corner of Lots Nos. 2 and 3; thence with the joint line of said lots, N 4-40 E 383 feet to a point in the center of said South Carolina Highway 106; thence with the center of said South Carolina Highway 106 the following: N 85-20 W 153.5 feet to a point, thence N 84-34 W 51.4 feet to the point of beginning.
