"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Berryhill Road, being shown and designated as Lot No. 3, Section II, Lake Forest Subdivision, dated Harch 1954, prepared by Piedmont Engineering Service, recorded in Plat Book EE at Page 71A and being described, according to said plat, more particularly, to-wit:
