TO ALL WHOM THESE PRESENTS MAY CONCERN:

THOMAS M. HARTER and MARICA B. HARTER, (hereinafter referred to as Mortgagor) SENDS GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of EIGHTEEN THOUSAND EIGHT HUNDRED AND NO/100

DOLLARS (\$ 18,800.00), with interest thereon as provided in said promissory note, principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the City of Greenville, S. C., on the southeastern side of Ridgecrest Drive in a subdivision named VISIA HILLS, being shown and designated as Lot No. 4 of said subdivision, plat of which is recorded in the R.M.C. Office for Greenville County, S. C., in Plats Book P, at Page 149, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Ridgecrest Drive at a point 75 feet southwest of the southerly corner of the intersection of Ridgecrest Drive and Wellington Avenue, the joint front corner of Lots Nos. 4 and 5, and running thence S. 38-19 E. 197 feet to an iron pin; running thence S. 58-00 W. 70 feet to an iron pin; thence along the joint line of Lots Nos. 3 and 4, N. 41-24 W. 177 feet to an iron pin on the southeastern side of Ridgecrest Drive; thence along the southeastern side of said Drive, N. 43-11 E. 80 feet to the point of beginning.
