TO ALL WHOM THESE PRESENTS MAY CONCERN: Donald G. Gibson and Evelyn M. Gibson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

DOLLARS

Five thousand eight hundred thirty-two and 96/100

(\$ 5,832.96), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is two years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

BEGINNING at an iron pin on the southeasterly side of Etowah Drive, which iron pin is the joint front corner of Lots 6 and 7 and running thence along said Drive N 62-0E 113 feet to an iron pin; thence S 28-0 E 137.5 feet to an iron pin; thence S 62-43 W 113 feet to an iron pin, the joint rear corner of Lots 6 and 7, thence N 28-0 W 135.9 feet to an iron pin, the point of beginning.

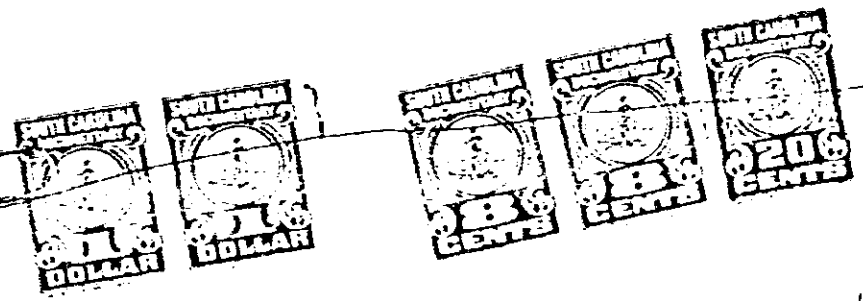
