BEGINNING at an iron pin on Windward Way, joint front corner of Lots 112 and 113 and running thence along Windward Way, S. 56-35 W. 64.2 feet to an iron pin in curve; thence along the curve, N. 78-25 W. 35.35 feet to an iron pin on Paddock Lane; thence along Paddock, N. 37-15 W. 50 feet to an iron pin; thence N. 44-55 W. 50 feet and N. 50-49 W. 27.4 feet to an iron pin; thence along the rear line of Lot 112, N. 56-35 E. 110.5 feet to an iron pin; thence along the joint lines of Lots 112 and 113, S. 33-25 E. 150 feet to an iron pin on Windward Way, the point of beginning.

BEGINNING at an iron pin on Rosebud Lane, joint front corner of Lots 126 and 127 and running thence with the joint line of said lots, S. 9-08 E. 150 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 126, S. 80-52 W. 100 feet to an iron pin on Paddock Lane; thence along Paddock, N. 14-14 W. 125.6 feet to an iron pin at curve; thence with curve, N. 33-18 E. 33.7 feet to an iron pin on Rosebud Lane; thence along Rosebud, N. 80-52 E. 88.4 feet to an iron pin, the point of beginning.
