TO ALL WHOM THESE PRESENTS MAY CONCERN: Robert J. Thompson, III and Jan Thompson  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Thousand Two Hundred and 00/100 ----- DOLLARS

(\$ 30,200.00 ---), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is -30- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Old Hickory Point, being shown and designated as Lot 13 of Section I on a plat of Forrester Woods Subdivision dated March 14, 1972, and recorded in the RMC Office of the Greenville County Courthouse in Plat Book 4N at Page 78 and being described according to said, more particularly, to-wit:

BEGINNING at an iron pin on the western side of Old Hickory Point at the joint front corner of Lots 13 and 14 and running thence with the common line of said Lots, N. 62-24 W. 150 feet to an iron pin at the joint rear corner of said Lots; thence along the rear line of Lot 13, N. 27-36 E. 110 feet to an iron pin at the joint rear corner of Lots 12 and 13; thence along the common line of said Lots, S. 62-24 E. 150 feet to an iron pin at the joint front corner of said Lots on the western side of Old Hickory Point; thence along Old Hickory Point, S. 27-36 W. 110 feet to an iron pin, the point of beginning.

The above described property is conveyed subject to all restrictions, easements, rights-of-way, and zoning ordinances of record or on the ground affecting said property.
