Thirty-Five Thousand Eight Hundred Fifty and No/100----- DOLLARS

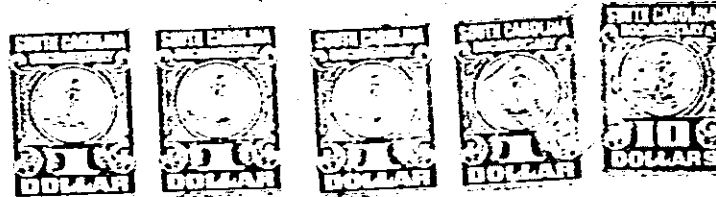

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 23 on plat of Old Mill Estates recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 000, at Page 159, and having, according to said plat, the following courses and distances, to-wit:
