WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifteen Thousand, Two Hundred and No/100 ----- DOLLARS

(\$ 15,200.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township, Town of Fountain Inn, being shown and designated as Lot No. 11 on plat of Property of Floyd and Mary W. Weathers, prepared by W.J. Riddle, dated March 28, 1952, amended by L. P. Slattery, March 19, 1953, and recorded in Plat Book DD at page 99, and being described according to said plat more particularly; to-wit:

BEGINNING at an iron pin on the northern side of an unnamed street (now Weathers Circle) at the joint front corner of Lots Nos. 11 and 12 and running thence with the common line of said lots, N. 67-37 W. 150 feet to an iron pin at the joint rear corner of said lots; thence along the rear line of Lot No. 11, N. 21-23 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 10 and 11; thence along the common line of said lots, S. 68-37 E. 150 feet to an iron pin at the joint front corner of said lots on the northern side of the aforementioned unnamed street; thence along the unnamed street, S. 21-23 W. 80 feet to an iron pin, the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the terms of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's amount and collect it as part
