**MORTGAGE**

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixteen Thousand Seven Hundred Fifty and No/100 DOLLARS (\$ 16,750.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the west side of Brown Road, being shown as Lot 5 on plat of Property of R. C. Ayres, made by C. O. Riddle, Durveyor, 11/2/71, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-N, at Page 46, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the west side of Brown Road at the joint front corner of Lots 4 and 5 and running thence along the common line of said Lots S. 88-44 W. 335.3 feet to a point; thence N. 1-16 W. 125 feet to a point; thence along the common line of Lots 5 and 6 N. 88-44 E. 371.8 feet to a point on the west side of Brown Road; thence along the said Brown Road S. 19-18 W. 36.6 feet to an iron pin; thence still with the said Brown Road S. 13-22 W. 93.8 feet to the point of beginning.
