WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Southwest-ern side of Seminole Drive, in the City of Greenville, Greenville Township, and being shown and designated as Lot 58 on Plat #2 of Sunset Hills, recorded in Plat Book "P" at page 19, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Seminole Drive, at the joint front corner of Lots 58 and 57, and running thence with the line of Lot 57, S. 48-50 W. 175 feet to an iron pin; thence N. 41-10 W. 75 feet to a pin, rear corner of Lot 59; thence with the line of Lot 59, N. 48-50 E. 175 feet to an iron pin on Seminole Drive; thence with the Southwest side of Seminole Drive, S. 41-10 E. 75 feet to the beginning corner.
