John W. Buswell and LaVon W. Buswell (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty Thousand and no/100----- DOLLARS

(40,000.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 40 on plat of Heritage Hill, recorded in Plat Book YY at page 187 and having the following courses and distances:

BEGINNING at an iron pin on Colvin Road, joint front corner of Lots 40 and 41, and running thence with the joint line of said lots, S. 9-45 E. 170 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 40, S. 80-15 W. 105 feet to an iron pin, joint rear corner of Lots 39 and 40; thence along the joint line of lots 39 and 40; N. 9-45 W. 170 feet to an iron pin on Colvin Road; thence along said road, N. 80-15 E. 105 feet to an iron pin, the point of beginning.

Being the same property conveyed by William R. and Barbara T. Russell by deed recorded herewith.
