General Partnership (hereinafter referred to as Mortgagor) SEND(S) CREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty Thousand and No/100

DOLLARS (\$ 30,000.00) with interest thereon as provided in said promissory note, said prin-

being described as follows:

Lot One: All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, Greenville County, South Carolina, being shown and designated as Lot 40, Block D, East Park, part of Boyce's addition to Greenville, S. C., as shown on a plat thereof recorded in the RMC Office for Greenville County in Plat Book A at page 383, reference being made thereto, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southern edge of Washington Road (also known as East Washington Street) at the joint front corner with Lot 39, as shown on said plat, and running thence with the southern edge of said Washington Road N. 85-30 E. 50 feet to an iron pin at the joint front corner of Lot 41 (being a property now or formerly of Parie Lee J. Greedo); thence with the joint line of said Lot 41 in a southerly direction 175 feet to an iron pin on the northern edge of Boyce Spring Avenue; thence with the northern edge of Boyce Spring Avenue, proceeding in a westerly direction 50 feet to the corner of Lot 39; thence with the joint line of Lot 39, in a northerly direction 175 feet to the point of beginning.

This being the identical property conveyed to the Mortgagor by deed of A. J. McKinney, to be recorded herewith.

Lot Two: All that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, in the City of Greenville, on the south side of East Washington Street, known as Lot 41, Block D on plat of East Park recorded in Plat Book A at page 383 in the RMC Office for Greenville County. This property is more specifically described on said plat as beginning at an iron pin at the corner of Lot 40 and running thence with the line of Lot 40 S. 17-30 E. 175 feet to an iron pin; thence N. 85-30 E. 50 feet to an iron pin at the corner of Lot 42; thence with the line of Lot 42, N. 17-30 E. 175 feet to an iron pin on West Washington Street; thence with Washington Street S. 85-30 W. 50 feet to the beginning corner.
