MORTGAGE

THIS MORTGAGE is made this 9th day of October 19 81, between the Mortgagor, Mr. David E. and Mrs. Vivian D. Zehr (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Nine Thousand Five Hundred and 00/100 Dollars, which indebtedness is evidenced by Borrower's note dated October 9, 1981 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on November 1, 1984;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein along the joint rear line of Lot No. 172 and Lot No. 3 N. 4-38 W. 125 feet to an iron pin; thence along the joint line of Lots Nos. 172 and 173 N. 86-32 E. 175 feet to the point of beginning.

This being the same property conveyed to the mortgagor(s) herein by deed of Richard L. and Mary P. Estes, and recorded in the RMC Office for Greenville County, on February 21, 1967, in Deed Book 814, and page 266.
