Discontinuance of the use of Geep Wedsworth, S. C.

Tt has been decided to discentiane the use of Gamp Wadsworth, with the exception of Base Hospital and Auxiliary Remount Depot thereat, with the least practicable delay, and to dispose of all supplies, equipment and transportation except that portaining to the Base Hospital and Remount Depot, and to salvage such proper-ty as is considered necessary, and this will be accomplished in such a way as to be for the best interests of the Government.

With this in view, you will demobilize all units at your camp including permanent camp organizations, not proviously ordered demobilized and discharge such of the enliated personnel as is eligible for discharge under general instructions issued or that hereafter may issue. Your attention is especially invited to current war Department Circulars that are applicable. All men enlisted prior to April 2, 1917, and others who desire to remain in the military service either permanently or temperarily will be retained in the service pending orders for their disposition. Report, attention Room 336, number, vecation, grade and arm of service of all men so retained.

The reduction of permanent camp organizations will be gradual and will keep page with the discharge of enlisted men and disposal of supplies, equipment and transportation, in order that the discentinuance of the use of Camp Wadsworth may proceed in a systematic manner and with the least practicable delay, until the personnel remaining is reduced to that necessary for the proper functioning of the Base Respital Resount Depot and the necessary caretakers who will be supplied from the personnel new as your camps. The caretakers will include men retained in service under paragraph 2 above, and Fire Rese and Truck Co.

The Chiefs of the interested Supply Departments have been directed to arrange for the prompt disposal of all supplies, equipment and transportation except those pertaining to the Same Scepital and Remount Depot and the Construction Division has been directed to salvage or otherwise dispose of the buildings axcept these pertaining to the Base Respital and Remount Depot, all supplies, equipment, transportation and buildings pertaining to the Supply Departments and Construction Division will be disposed of by you only in accordance with their instructions. You will separate with the Chiefs of the Supply Departments and Construction Division in every way possible in order to expedite the closing up of your camp. Upon the abundancent of any portion or all of your

Comp, you will turn it over to the representative of the Construction Division who will thereafter take responsible charge of the abandoned facilities and all salvage work under the direct supervision of the Chief of the Construction Division.

You will inform, without delay, the nearest representatives of all volunteer organizations which have erected buildings at your camp that the use of the camp is to be discentimed and will request that they remove their buildings from the camp or otherwise dispose of them as they see fit.

Enlisted men not eligible for discharge by reason of physical condition will be segregated into groups according to the states from which they were drafted or inducted into the service, and will be transferred in accordance with Circular #14, War Department, 1919, and such other War Department circulars as may apply in each case, to a demobilization camp in or near their respective states, after arrangements have been made by you with the Gressending Officer of the camp to receive them.

When the reduction of the personnel at your camp makes necessary much action, you are authorized to transfer all prisoners at your easp, except these pertaining to the base Respital and Resount Depot to the nearest deschilization camp, after arrangements have been made by you with the commanding officer of the proper camp to receive them.

The Chiefs of the Staff Corps have been directed to advise you as to the disposition of specially qualified enlisted men of their Corps required at other Camps, and you will transfer such men in accordance with their instructions, provided that no man who has established the merit of his claim to discharge under Circular 77. War Department, 1915, will be so transferred. All other enlisted men of Staff Corps Organizations at your emp will be discharged as provided in paragraphs 2 and 6 above.

Officers will be disposed of as provided for in general instructions which have been or may hereafter be issued from this office.

War Department, A. G. O., Jamuary 50, 1919- To all Eurean Chiefe, for their infermation and who are directed to make recommendations without delay to the Commanding General, Camp Madsworth, S. C. for the disposition of enlisted personnel in their Corps at this camp which they desire to retain in the service and have transferred elsewhere. They will request the retention only of specially qualified men and reduce the master requested to the minimum.

The Director of Burchase, Storage and Traffic, the Chiefs of all Supply Departments and the Construction Division are directed to ismue the necessary instructions without delay for the disposal of such supplies, equipment and transportation as pertain to their respective departments, except those pertaining to the Base Despital and Remount depot and for such salvaging of property as is considered necessary with view to discentinuing the use of Camp Valsworth at the earliest practicable date and to dispose of all supplies, equipment and transportation now at Comp Valsworth except such as pertain to the Base Respital and Remount Depot in such a way as will be for the best interests of the Severament and to sulvage such property as it is considered necessary to salvage for the best interests of the Government. The Commanding Conoral, Comp Wadsworth, has been directed to reduce the permanent same organizations gradually, keeping pace with the discharge of enlisted men and the disposal of supplies, equipment and transportation, until the personnel remaining at Camp Wadsworth is reduced to that necessary for the proper functioning of the Base Bospital and Bosount Depot and to coretakors for the remainder of the camp who will be supplied from the personnel mow at Camp Wadsworth. The caretakers will include the Fire Hose and Truck Company new at this camp. The Commanding Conoral, Comp Wadsworth, has been directed to notify the nearest representatives of all volunteer organizations which have ercoted buildings at that damp, that the use of the damp is to be discontinued, and has been directed to request that they remove their buildings from the comp or otherwise dispose of them as they see fit.

The Director of Purchase, Storage and Traffic will cancel leases only in accordance with instructions based on recommendations received from the Construction Demobilization Committee of the General Staff.

The Chief of the Construction Division will salvage buildings only in secondaries with instructions based on recommendations
reserved from the Construction Demobilization Committee of the Construction
Staff.
