
1. Your attention is invited to paragraph 4 of 1st Indorsement by your office attached to letter of April 9, 1919 from the Real Estate Service to Department Quartermaster, Southeastern Department, subject real estate occupied but not owned by the United States. The question #7 on Form Four - Renewals, does not call for information as to the disposition intended by the War Department of the various Government improvements as suggested in the paragraph of your indorsement referred to above. The information desired is the cost of the improvements thereon, and a brief description of such improvements.

It is noted that in very many instances question 2. #7, Form Four - Renewals, has been answered by your office, "Information not available in this office."

3. It is of vital importance to this office that information as to the cost and a brief description of the improvements on the property be forwarded to this office, in order that the necessary action may be taken to guard the interests of the Government in regard to these improvements prior to the ending of the present fiscal year.
