KNOW ALL MEN, that FRANKLIN ENTERPRISES, INC., a Corporation, is the owner in fee simple of lands which it has caused to be subdivided as a subdivision named HOLLY TREE PLANTATION, Phase II, Section IIIB, as shown on a plat which is on file in the office of the County Planning Commission of Greenville County, and a copy of which upon approval by the County Planning Commission will be recorded in the office of the County Register of Mesne Conveyance. That the Corporation freely offers, grants and dedicates to those who may purchase said property or any part of it, to the general public and to Greenville County the use and control of the streets and roads shown on said plat of property for public use.
