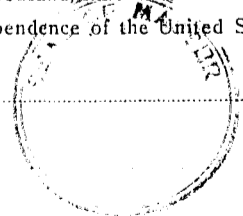
lot or parcel of land situate in the City of Greenville, County and State aforesaid, and having the following metes and bounds, to-wit:
