Gray, All those three certain lots of land situate in the County and State aforesaid, in the City of Greenville, in Ward No. 5, and being known and designated on plat recorded in Plat Book A, page 403, as lots Nos. 3, 4, and 10, and having the following metes and bounds, to wit:

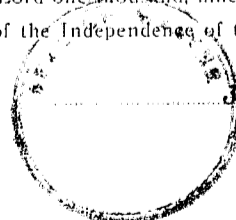
