WHEREAS, Carolina Loan & Trust Company,

NOW, THEREFORE, Know all men by these Presents, that I, J. W. Gray, Master in and for County of Greenville, aforesaid, in consideration of the sum of Three Hundred Dollars, to me paid by the said John H. Earle,

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said John H. Earle - all that certain tract or parcel of land situate in the City of Greenville, County and State aforesaid, and having the following metes and bounds to-wit: Beginning 147 1/2 feet from an iron pin and corner of lot of Susan Mitchell, in Birnie Street, and running thence parallel with Birnie Street N. 61 1/2 W, 66 feet and 8 inches to an iron pin in line of Susan Mitchell; thence S. 28 1/2 W, 70 feet to an iron pin in corner of above lot; thence 61 1/2 E, 66 feet and 8 inches to an iron pin in corner known formally as J. S. Donaldson's lot; thence N. 28 1/2 E, 70 feet to beginning corner. This being the same lot of land conveyed to Emma C. Butler by Susan Mitchell, by deed dated September 5th, 1911, and recorded in R. M. C. Office for Greenville County in Vol. 10, page 357.

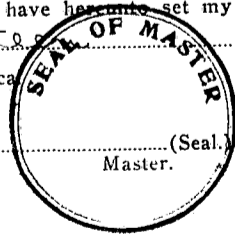
