WHEREAS, John L. Walker, et al,

on or about the 22nd day of January in the year of our Lord nineteen hundred and fourteen exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against

Asa W. Green, as Executor of the last Will and Testament of W. Howell, deceased, et al,

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 20th day of March 1914, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be sold by J. the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said J. J. McSwain, all that certain parcel or lot of land situate in Ward 2, of the City of Greenville, in the County and State aforesaid, known as lot no. 1 in the plat of survey of the lands of which Martha J. Howell died, seized and possessed, made by W. C. Adams, surveyor, on the 10th day of March, 1914, having the following metes and bounds, to-wit: - Beginning at a stake on North Street and running thence with said North Street n. 7 1/4 E. 60 feet to a stake, corner of lot no. 2; thence n. 22 1/2 W. 103 feet to a stake, corner of lot no. 2, on unnamed Street; thence along unnamed Street n. 69 W. 68 feet to a stake on said Street; thence S. 39 1/4 W. 14 feet to a stake; thence S. 22 1/2 E. 138 feet to the beginning corner.
