TO ALL WHOM THESE PRESENTS SHALL COME: I, J.W. Gray, Master in and for the County aforesaid, SEND GREETING: WHEREAS, J.J. Lister, Mary A. Henson and Sallie Henson

on or about the 25th, day of August in the year of our Lord nineteen hundred and eleven exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against J. Robert Prewette and D. Jackson Prewette

demanding that the real estate described in the complaint be partitioned among the parties interested therein; and the cause being at issue, came on to be heard on the 12th, day of December 1911, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by J.W. Sallie Henson, all that tract of land situate in the County and State aforesaid, known as Lot No. 1, on plat of survey of lands of D.C. Lister, deceased made by J.H. Atkins, bearing date 30th, day of August, 1911, consisting of two separate tracts, containing thirty-nine and 82/100 acres, and the other containing seven and 19/100 acres, aggregating forty-seven and 1/100 acres. The second tract has the following metes and bounds, to wit: Beginning at a stone corner of Lot No. 4, and running; thence 77 E. 2.60 to a stone; thence N. 8-1/4 E. 1.60 to a stone; thence N. 31-1/2 E. 7.20 to stone; thence N. 5-1/2 W. 3.09 to a stone; thence N. 19-3/4 E. 2.46 to a stone; thence N. 64-3/4 W. 5.64 to stone; thence S. 16-1/2 W. 1.85 to a stone; thence N. 80 W. 4.51 to a stone; thence S. 45-1/2 E. 5.46 to a stone; thence S. 1 E. 6.86 to a stone; thence S. 25-1/4 W. 2.50 to a stone at the beginning corner.
