I, J.W. Gray, Master in and for the County aforesaid, SEND GREETING: WHEREAS, Richard Hall

on or about the First day of January in the year of our Lord nineteen hundred and thirteen exhibited his complaint in the Court of Common Pleas, for the County aforesaid, against Samuel A. Hall et al.

demanding that the real estate described in the complaint be partitioned among the parties interested therein; and the cause being at issue, came on to be heard on the seventh day of October 1913, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by J.W. Gray Master in and for the County aforesaid, to Joseph Hall for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. 4279).

NOW, THEREFORE, Know all men by these Presents, that I, J.W. Gray Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Joseph Hall, All that certain lot or parcel of land just outside the corporate limits of the City of Greenville, County and State aforesaid known as lot 4 in the plat of survey of land of James E. Hall deceased, recorded in R.M.C. office of Greenville County in Book C. page 89 having the following metes and bounds to wit: Beginning at a stake on 20 foot road, corner of lot No. 3, and running thence S. 66°-20' W. 242' with said road to stake corner of lot No. 5 thence S. 23°-40' E. 256' to a stake; thence N. 66°-20' E. 513' to stake in middle of Nickletown Road; thence down center of said Road N. 0°-30' E. 139' to stake at intersection of 20 foot road with said Nickletown Road; thence along said 20 foot road 336' to the beginning corner.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever, of the parties to the cause aforesaid, and of each of them in and to the same; and all other persons rightfully claiming from, under, or any of them.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned, unto the said Joseph Hall, his heirs and assigns forever.
