KNOW ALL MEN BY THESE PRESENTS, That I, W. A. Bates, of Greenville County and

in consideration of the sum of Fifteen hundred (\$1500.00) in the State aforesaid to me in hand paid at and before the sealing of these presents by Mrs. Annie S. Watkins, wife of J. R. Watkins

is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Mrs. Annie S. Watkins, Wife of J. R. Watkins, and her heirs

and assigns forever, All that certain piece parcel or lot of land situate, lying and being in the State of South Carolina, County and Township of Greenville, on the Spartanburg Road, near the City of Greenville, and having the following Metes and Bounds, according to a plat made of a subdivision of the property of W. A. Bates, bearing date May 1915 by R. E. Walton, Engineer, to wit: Beginning at an iron pin on the North side of the Spartanburg Road, corner of the John Thompson property, and running thence with line of said property N. 40-27 W. 317 feet to an iron pipe on line of the said Thompson property; thence N. 70-08 E. 150 feet to an iron pipe, corner of lot No. 2, in subdivision of W. A. Bates property. Thence with line of lot No. 2, S. 24-51 E. 300 feet to an iron pipe on the edge of Spartanburg Road; thence with the North side of Spartanburg Road S. 71-46 W. 65 feet to an iron pin the beginning corner, this being a portion of the land conveyed to me, the said W. A. Bates by A. E. Payne by a deed bearing date 7th day of September, 1912 and recorded in the R. M. C. for Greenville County in the State of South Carolina, in Volume No. 21 of Deeds, at page 288.

Watkins, and her heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
