NOW, KNOW ALL MEN BY THESE PRESENTS, That I, R. L. Lindsey

in the State aforesaid
in consideration of the sum of Three hundred and Ninety five (\$395) DOLLARS,
to me in hand paid at and before the sealing of these presents by Paul Carson

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Paul Carson all that piece, parcel or tract of land situate lying and being in the State and County aforesaid in Highland Township one the head waters of Tyger River, and has the following metes and bounds "to-wit" Beginning in what is known as the spring branch, at a stake, thence down and with the meanderings of said branch as a line 6.97 chs. to its confluence with a larger branch; thence up said (larger) branch 17.39 chs. to a small branch; thence up said small branch 18.08 chs. to a poplar, thence N. 88 E. 1.85 ch. to a stone; thence N. 2 E 7.00 chs. to a stone on top of hill; thence N. 15 W 12.22 ch. to the beginning corner, containing twenty six and one (26 1/3) third acres, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Paul Carson and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Paul Carson and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
