Hart, all our interest in the following described piece parcel or lot of land situate lying and being in the City of Greenville as follows: Beginning at a stake on Green Ave. one hundred and thirty feet from the Right of Way of the C & G. R. R. and running thence north one hundred feet to a stake, thence West twenty feet to a stake, thence south one hundred feet to a stake on Green Ave, thence east twenty feet to the beginning corner, being parts of lots Nos. 1 & 2 as shown on plat recorded in the R. M. C. Office for Greenville County in plat Book C, page 511.
