(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
J. I. Hesterfelt, all that certain lot of land situate on
the east side of Jones Street in the 13th ward of the
City of Greenville, County and State aforesaid, more par-
ticularly describing as follows: Beginning at a stake on
the east side of Jones Street corner of the lot conveyed by
J. O. Belton to Mottie Gilreath, and running thence
with Jones Street in a southerly direction 50
feet to a stake corner of the lot conveyed by W. A.
Barton to Mottie W. McGee, Executive; thence with the
line of the last mentioned block in a southeasterly
direction 150 feet to a stake in Myrtle's line, thence
along Myrtle's line in a westerly direction 50
feet to line of lot conveyed by J. O. Belton to Nira
Thompson; thence with Nira Thompson's line in a
northwesterly direction 50 feet to Mrs. Gilreath's line,
thence with her line along the same course 50 feet
to a stake corner of the same lot of land
