(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

all that certain lot of land situate at Paris in the County of Greenville, State of South Carolina, known and designated as lot #2 of the property of W. D. Parrish as shown on Plat made by R. E. Dalton and recorded in Plat Book "E" page 46, and having the following metes and bounds:
