NOW, KNOW ALL MEN BY THESE PRESENTS, That I, W. D. Parrish

in consideration of the sum of Ten (\$10.00) Dollars and other considerations in the State aforesaid to me in hand paid at and before the sealing of these presents by Blinton J. Morgan and Jas. H. Morgan, Jr.

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Blinton J. Morgan and Jas. H. Morgan, Jr. all that certain lot of land situate in Blitch Springs Township, County of Greenville and State of South Carolina, known and designated as lot #8 of subdivision of lots of W. D. Parrish at "Paris" as shown on plat recorded in R. M. C. Office for Greenville County in Plat Book "E" page 46 and more particularly described as follows:

Beginning at an iron pipe on the west side of Mooney Road at corner of lot #7 and running thence with Mooney Road N. 32-42 W. 20 feet to stake, corner of lot #9, thence with line of lot #9 S. 57-18 W. 101.5 feet to stake; thence S. 30-42 E. 12.3 feet to iron pipe; thence S. 36-43 E. 10 feet to stake, corner of lot #7; thence with line of lot #7, N. 56 W. 98.8 feet to the beginning corner, being a portion of the land conveyed to me by Realty Corporation -
