NOW, KNOW ALL MEN BY THESE PRESENTS, That W. D. Parrish  
in consideration of the sum of Ten Dollars and other considerations in the State aforesaid  
to me in hand paid at and before the sealing of these presents by B. O. Hollis

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

B. O. Hollis  
all that certain lot of land, situate, lying  
and being on the national Highway, at Paris,  
State of South Carolina, County of Greenville,  
and being a portion of the land conveyed to  
me by O. S. Miller.

Beginning at a pipe on the northwest corner  
of the national Highway and a fifty foot street,  
and running thence with fifty foot street  
n. 36-43 W. seventy-five (75) feet to an iron pin,  
thence S. 53-40 W. twenty-five (25) feet to a stake;  
thence S. 36-43 E. seventy-five (75) feet to a pin on  
national Highway; thence with national  
Highway n. 53-40 E. twenty-five (25) feet to  
the beginning corner. Said corner being  
three hundred and twenty-five (325) feet  
from the northwest corner of national  
Highway and Mooney Road, according  
to a survey of R. E. Batcher, Engineer.

every person whomsoever lawfully claiming or to claim the same, or any part thereof.
