NOW, KNOW ALL MEN BY THESE PRESENTS, That I, W. S. Shackleton of Fountain Inn, in the State aforesaid in consideration of the sum of Three Hundred and Seventy Five DOLLARS, to me in hand paid at and before the sealing of these presents by M. S. Wood

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said M. S. Wood, all that lot or parcel of land lying being and situate near the south of Fountain Inn in County and State aforesaid containing two and one half acres more or less and hath the following metes and bounds to wit: Bound by said Wood & myself commencing at a point in old road near the residence said M. S. Woods, running thence S. 37 1/2 W. 1.00 to a stone, thence S. 49 1/4 E. 7.26 to a stone on new road, thence N. 6 1/4 W. 5.96 to a stone, thence N. 51 3/4 W. 5.00 to a stone in center of old road thence S. 6 W. 3.50 to beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said M. S. Wood and his heirs and assigns, forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said M. S. Wood and his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
