line 72 yards to stone in J. B. Belcher's line,
running parallel with B. W. Moon line
to stone in that / lead by Moon Home in
to Jordan, thence 72, with W. D. Hughes line
to stone at B. W. Moon line, thence with
B. W. Moon line to the beginning corner
containing six & fourth acres more or less.
