(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Steg Nick Varoulas & Pete G. Farlidas, all that lot or parcel of land, lying, being and situate in the City of Greenville, in the County of Greenville, in the State of South Carolina, on the East side of Rowley Street, Beginning at a stake on Rowley Street and running thence along said Street S. 20-19 W. Fifty five feet to a stake, thence S 71.50. E. one hundred and ninety two feet and seven inches to a stake; thence N 20-19 E. Fifty five feet to a stake; thence N 71-50 W. one hundred and ninety two feet and seven inches to the beginning and known as Lot No. 5 in section 4 in a plat of the Stone Land Company, recorded in Plat Book 2, page 339; and being the same lot of land heretofore conveyed to me by E. E. Chandler on the 29th June, 1914, by his Deed duly recorded in the office of R. M. C. for Greenville County, in Deed Book 27 at page 428.
