(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release
 unto the said John M. Gear, All that piece, parcel or lot of land situate in the second Ward,

City of Greenville, County of Greenville, and State of South Carolina, more particularly described as follows: Beginning at a point on the North side of East Coffee Street, at the center of a brick wall, being the southwest corner of the lot conveyed by Henry T. Mills to W.N. Watson, and being forty (40) feet west of the Northwest corner of Coffee and Brown Streets, as now located, and running thence with the center of the said brick wall and along the west line of lot conveyed by Henry T. Mills to W.N. Watson North 21, East one hundred (100) feet to Gibson's line; thence along Gibson's line North 69-40 West sixteen and 9/10 (16.9) feet to stake, the northeast corner of lot sold by H.T. Mills to Sarah W. Bates; thence with the line of the last mentioned lot, passing along the center of a brick wall, South 21-17 West one hundred (100) feet to a point on the North side of Coffee Street at the center of said brick wall, said point being forty (40) feet East of the Southeast corner of the Cauble property; thence with Coffee Street South 69-30 East seventeen and 25/100 (17.25) feet to the beginning corner, being the middle portion of the lot conveyed to Henry T. Mills by Alice E. Freeman individually, as Trustee by deed dated November 14th, 1913, recorded in R.M.C. Office for Greenville County in Vol. 23, page 368, being the same parcel of land conveyed by Henry T. Mills to J. Hudson Williams and W.A. Hudson Williams by deed dated August 21st, 1916, recorded in said R.M.C. Office, Vol. 41, at page 48; and the one-half interest of W.A. Williams by deed dated June 29th, 1916, recorded in R.M.C. office said Greenville County, in Vol. 35, page 198. The division line between the lot hereby conveyed and the adjoining lot belonging to S.W. Bates runs through the center of the brick wall of the store hereby conveyed, I having heretofore conveyed my half interest in same to S.W. Bates, by deed dated October 3rd, 1917, recorded in R.M.C. Office, said Greenville County, in Volume 33, page 286.
