(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Nancy Jane Page, All that certain lot of land situate just outside of the

the corporate limits of the City of Greenville, County and State aforesaid, known as lot number ninety-nine (99) on plat of survey of lands of W.M. Norwood, known as Norwood Heights, as shown on Plat recorded in plat book A., page 133. Said lot has a frontage of fifty (50) feet on Main Street and a depth of one hundred & fifty (150) feet and being the same lot of land conveyed to me by W.M. Norwood by deed dated December 7, 1916 and recorded in deed book 41, page 475.

Also all that other certain piece, parcel or lot of land situate, just outside the corporate limits of the City of Greenville, County and State aforesaid, known as lot number ninety-eight (98) in plat of survey of land W.M. Norwood, known as Norwood Heights as shown on plat recorded in plat book A., page 133. Said lot has a frontage of 50 feet on Main Street and a depth of 150 feet and being the same lot of land conveyed to me by W.M. Norwood by deed dated Dec. 7, 1916 and recorded in deed book Vol. 41, page 474.
