KNOW ALL MEN BY THESE PRESENTS, That we D. M. Levi and Victoria S. Levi of the City of Greenville

in the State aforesaid,
in consideration of the sum of Five Dollars and other valuable considerations DOLLARS,
to us in hand paid
at and before the sealing of these presents by H. I. Henderson of said City,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said H. I. Henderson

All that piece, parcel and lot of land, situate being and being in Grove Township in the County and State, adjoining lands of C. F. Riddle and others, containing thirty five (35) acres, more or less, and having the following metes and bounds, to wit, Beginning at a holly, on branch and running thence down said branch N. 40° E. 11.04 to stone 37; thence S. 50 1/2° E. 2.40 to iron pin 37; thence N. 23° W. 7.87 to iron pin 37; thence N. 21 1/4° W. 7.83 to iron pin in road 37; thence with said road S. 87 3/4° W. 17.35 to stone 37; thence S. 10 1/8° E. 14.20 to stone 37; thence S. 72.20° E. 6.12 to branch; thence down said branch to the beginning (holly) corner, being the same tract of land conveyed to us by C. F. Riddle by his deed bearing date August 26th 1914, and recorded in the W. M. C. Office for Greenville County in Vol. 37 page 318.
