Office for said County in Plat Book C, page 59; Beginning at an iron pipe on Spring Street at the corner of a ten foot alley and 110 feet south from the corner of East Washington and Spring Streets, and running thence S. 22-42 W. 90 feet to an iron pipe, corner of lot of W.C. Cleveland; thence N. 69-39 W. 101.7 feet to iron pipe; thence N. 21-55 E. 90 feet to iron pipe on said 10 foot alley; thence with said alley S. 69-39 E. 103 feet to the beginning corner. Icard and Ernestine Icard by deed dated February 24th, 1917, and recorded in Book 46, page 130.

Also all that other lot of land in the Township, County and State aforesaid, known as lot No. 5 in Block K. of City View Land Company's land as shown by plat recorded in plat Book A, page 327, fronting on Brandon Road sixty-five feet and ten inches, and running back in parallel lines one hundred and forty-six feet; being one of the lots conveyed to me by Gertrude T.
