

W. Ross Harris DEED TO Mrs. Ida O. West,

 in consideration of the sum of Ten & no/100 (\$10.00) and other valuable considerations  
 to me paid by Mrs. Ida O. West Dollars,  
 in the State aforesaid, the receipt whereof is hereby acknowledged, have granted bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Mrs. Ida O. West  
 all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina and County of Greenville, near the City of Greenville, on the Spartanburg Road and having the following lines, metes and bounds, to-wit:  
 Beginning at a pipe in the edge of the Spartanburg Road and running thence with Watkins' line N. 30-27 W. 312 feet to a pin Watkins' corner; thence with the rear line of said Watkins' N. 81-38 E. 25 feet to Watkins' corner; thence N. 40-27 W. 84 feet and 3 inches running across a small branch to pipe corner just beyond branch; thence S. 22-30 W. 81.8 feet to a pipe corner on line; being the rear line of Watkins' projected (said rear line being S. 81-38 W.); thence S. 24-45 E. 323 feet to a pipe on edge of the Spartanburg Road; thence the edge of said road N. 69-32 E. 70 feet to the beginning corner. This deed conveys a lot fronting Spartanburg Road 70 feet and running back on approximately parallel lines so that it narrows to a width of 60 feet on the rear line.  
 Also a triangular space partly in the rear of Watkins' lot, so as to cross the branch. The length of said lines are measured from the edge of said Spartanburg Road. Office for said County and State in Volume #52 of Deeds, at page 103, to which reference is hereby made.

 in the State aforesaid, the receipt whereof is hereby acknowledged, have granted bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said M. M. Grantt  
 all that piece, parcel or lot of land in \_\_\_\_\_ Township, Greenville County, State of South Carolina.

all that certain piece, parcel or lot of land, situate, lying and being on the Piedmont or Iron Road, near the Corporate limits of the City of Greenville, known as Lot no. 5 of a subdivision of land known as South Cherokee Park, as represented by a plat made by J. W. Willis, surveyor, July 1st, 1906, plat recorded in R. M. C. Office for Greenville County, in Plat Book A, at page 130, and having the following metes and bounds, to-wit: Beginning at an iron pin on said Piedmont road, corner of lot no. 4, and running thence after allowing a side walk of ten feet along the road N. 27 E. Sixty (60) feet to an iron pin, corner of Lot no. 6; thence S. 65 E. one hundred seventy-two feet to an alley; thence S. 27 W.
