KNOW ALL MEN BY THESE PRESENTS, That I Abner B. Curreton, of Greenville County, in the State aforesaid, in consideration of the sum of Twenty-two hundred fifty and no/100 (\$2,250.00) Dollars, to me paid by Mary G. Holroyd

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Mary G. Holroyd, all my undivided right, title and interest in and to the same being an undivided lot in the Township, Greenville County, State of South Carolina, all that piece, parcel or lot of land in Greenville

On the City of Greenville, having the following metes and bounds, to wit: Beginning at an iron pin on Pendleton Street, at corner of O. K. Mauldin lot; one hundred and sixty one feet from the corner of Leach and Pendleton Streets; thence with said Pendleton Street, East Seventy feet to an iron pin (Lawton's corner); thence in a Northwesterly direction one hundred and ninety one feet to an iron pin on an alley; thence with said alley, west seventy feet to an iron pin (Mauldin's Back corner); thence in a Northwesterly direction, along said Mauldin line to the beginning corner; being the lot conveyed to Alvin H.
