KNOW ALL MEN BY THESE PRESENTS, That Miller Realty Company

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of One hundred Dollars and other valuable considerations...

His heirs and assigns. That certain lot of land situate in the City of Greenville, County and State aforesaid, on the East side of Main Street, being lot no. 1 as shown on a plat made by R. E. Dalton, Engineer, December 1919, and having the following metes and bounds, to-wit: Beginning at the North West corner of the wall of property now owned by Beattie on the East side of Main Street; thence with said street N. 19 E. 27 feet 6 inches to an iron pin on Court; thence S. 70-34 E. 56 feet 5 inches to a point in line of lot no. 2; thence with line of lot no. 2 S. 17-33 E. 26.8 1/2 inches to a point in wall; thence S. 70-55 E. 101 feet 2 inches to a point in said wall on Eastern line of lot No. 2; thence with said line N. 12-42 E. 8 1/2 inches to a point on the foot alley; thence S. 70-55 E. 10 feet 8 1/2 inches across said alley to a point in brick wall; thence S. 19-05 E. 58 feet 1 1/2 inches to a point on line of J. E. Surine; thence with Surine's line N. 70-52 E. 49 feet 4 1/2 inches to a point in line of Beattie property; thence with said line N. 19-05 E. 30 feet 8 inches to a corner of said Beattie property; thence again with line of said Beattie property N. 70-31 E. 119 feet 1 inch to the beginning point. Together with the right to use the eleven-foot alley extending East from the East corner of said building to Falls Street; said alley lying between the property of C. C. Hindman and J. E. Surine.

Also that other lot of land, being lot no. 3 as shown on said plat, having the following metes and bounds: Beginning at a point on the North East corner of a ten foot alley and East Court Street; thence with line of said Street S. 71-39 E. 30 feet to an iron pin corner of lot no. 4; thence with line of said lot S. 18-21 N. 100 feet to an iron pin on an eleven foot alley; thence with line of said alley N. 71-39 E. 29.3 feet to a point at Eastern line of lot no. 1; thence with line of said lot N. 19-05 E. 46 feet 1 inch to a point at the North East corner of lot no. 1; thence with line of said lot N. 70-55 E. 5 feet 8 1/2 inches to the middle of ten foot alley; thence N. 17-42 E. with middle of said alley 53 feet 11 inches to a point on East Court Street; thence S. 71-39 E. 30 feet to the beginning corner. 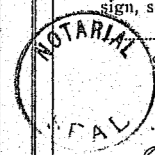

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Ten dollars and other valuable considerations...

All that certain lot or parcel of land situated in Ward two of the City of Greenville, County and State aforesaid, and having the following metes and bounds: Beginning at a stake in the East line of Pettigree St. Corner of lot #4, run north 64° 56" East with the East line of Pettigree Street 60 ft. to a stake at the corner of Pettigree and on Toy Street, thence with the line of Toy Street 15° 0" East 140 ft. to a stake in the West line of a ten foot alley, thence with the line of the alley South 64° 56" West 46.2 feet to a stake in corner of lot #4, thence with the line of lot #4 north 20° 35" West 138.4 feet to the beginning corner. Being known and designated as lot #5 on a plat of the property of Thomas F. Parker, Surveyed February 1916 and revised April 1919 by R. E. Dalton, Engineer, recorded in R. M. This property or any part thereof is not to be sold, rented, or otherwise disposed of to persons of African descent and no part of any building shall be nearer Pettigree St. than 20 feet. In event of a violation by the purchaser of either of the restrictions above made the title to this tract shall revert to the grantor, except as against lien creditors.

The above described property was conveyed to C. M. Bauskett by Thomas F. Parker, under deed dated April 18, 1919 and recorded in office of R. M. C. for Greenville County in Book E page #115. 50-313
