a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Five DOLLARS, and other valuable considerations to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

W.D. Workman, his heirs and assigns;
All that certain piece, parcel or lot of land in the City of Greenville, County and State aforesaid, being known as Lot No. 2 on plat of property of R.J. Rowley, made November, 1923, and being described according to said plat as follows:
Beginning at a point on the South side of West Coffee Street, front corner of Lots Nos. 1 and 2, and running thence along line of Lot No. 1, S. 21-14 N. 60.61 feet to point on line of Church property; thence with said Church Property, N. 66-21 N. 20.02 feet to point, joint corner of Lots Nos. 2 and 3; thence along line of Lot No. 3, N. 24-14 E. 59.52 feet to point on West Coffee Street; thence with West Coffee Street S. 69-20 E. 20 feet to the beginning corner. This being one of the lots conveyed to the Grantor by R.J. Rowley.

As a part of the consideration for this conveyance, the Grantor assumes and agrees to pay according to its terms, a certain note, secured by mortgage covering the above described lot, executed by Greenville Realty & Investment Company to R.J. Rowley, dated December 14, 1923, maturing on or before 10 years after date, with interest from date at the rate of 6% for the first five years, and with interest from December 14, 1928 at the rate of 7%, said mortgage being in the sum of \$13,350.00, and being recorded in the R.M.C. Office for Greenville County, in Vol. 110, Page 265.
Grantor is to assume interest from date of said mortgage.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
