Whereas, W.H. Gaillard, is desirous of committing the care, maintenance, education and support of his child, Inez, to J.H. Gaillard. -

And Whereas, the said J.H. Gaillard agrees to accept the care, custody, maintenance, education and support of the said Inez during her minority, and further agrees that he will, by proper devise and bequest make her equal with his own children in the distribution of his estate, and that he will further hold and manage all of the property of the said Inez and the increase thereof for her separate use until she is married or arrive at the age of twenty one years; Now, Therefore, Know all men by these presents, That I, W.H. Gaillard for and in consideration of the premises herein stated, have agreed to and do hereby commit the care, custody, maintenance, education and support of my child, Inez of the age of Six years, for and during her minority.

Together with the rights, privileges and benefits that could be exercised by me, as parent, over and in respect to the said Inez.

To have and to hold, the said Inez against me and any and all persons claiming or to claim any interest, right or privilege through me in and to the said Inez.
