 to me in hand paid at and before the sealing of these presents by W.K. Livingston

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said W.K. Livingston, his heirs and assigns, all of that lot of land situate at the Northeast corner of Washington Road and Williams Street, and more particularly described as follows:  
 Beginning at an iron pin at the Northeast intersection of said Road and Street and runs thence along Washington Road N. 68.52 E. 91 feet to the center of lot No. 9; thence N. 14.54 W. 140 feet to a ten foot alley; thence along said alley S. 68.52 W. 91 feet to Williams Street; thence along Williams Street S. 14.54 E. 140 feet to beginning corner, being all of Lot 8 and one-half of lot 9 as shown on plat book "E" page 115 in R.M.C. Office for said County and State and conveyed to me by deeds recorded in Vols. 87 page 504 and 87, page 505.
