W. Burdette, the Wilson Property and others, and known as the White Oak Poultry Farms lot. Together with all machinery, furniture and fixtures, brooder houses and appurtenances used, owned or operated in connection with said Corporation's affairs, and all other Property owned by it where-so-ever located.
