Norwood, all that certain piece, parcel or lot of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Kanatenah", and known as Lot #15, in Block "C" on revised plat of the said property to be recorded in R.M.C. Office for said County.

The said lot has the following metes and bounds: beginning at a stake on the south side of Stewart Street, at corner of Lot #14, and running thence along said street, eastwardly, sixty feet to stake at corner of lot #16; thence along said lot one hundred and sixty-five feet to stake at corner of lot #6; thence along said lot, sixty feet to a stake at corner of lot #14; thence along said lot one hundred and sixty-five feet to the beginning point on said Stewart Street.
