All that lot, piece, or parcel of land in the County of Greenville, State of South Carolina, known and designated as Lot 720, 11745 of Plat No. 1, of the property of the Inyon Development Company, known as Lake Lanier, made by George Arshwin, Jr., and duly recorded in the office of R. M. Co. for Greenville County in Plat Book Page 10.
