Greenland Township, on the north side of Sunrise Drive  
and having the following metes and bounds to wit:

Beginning at a stake at Lot #15, formerly deeded to J. P.  
Washpelt, and running thence with Sunrise Drive S. 32-13  
E. 50 feet to a head on the road, thence S. 55-32.6 E. 50 feet to the  
corner of Lot #14; running thence with the line of Lot #14 N. 34-32  
E. 200 feet to a stake, running thence in a northeasterly direction  
59.8 feet to the corner of Lot #15, running thence S. 45-30 E. 200
